From: The Critical Response Committee under UCR's Black Faculty and Staff Association (BFASA)

Towards the second half of July 2022, a BFASA member (named removed for confidentiality) was exposed to an unsafe and hostile work environment due to an act of vandalism that included the word "**Nigger**" spray-painted on a wall in the building this BFASA member passes by frequently when in the office. This staff member was made aware that the perpetrators were identified and arrested soon after the vandalism occurred, but this, however, did nothing to lessen the strong feelings of fear and concern that are still present. Little to no follow up has been given to the BFASA member impacted by this situation. Hostile acts like this are not new to UCR as multiple staff and faculty members can attest to experiencing similar acts of vandalism that include the use of hate speech. These hostile acts however, have not been shared with the campus community and have been treated as localized occurrences.

BFASA is extremely concerned that this is a culture problem on our campus, where situations like this can happen to faculty and staff without proper notification from leadership or support provided to those affected. We must recall the third pillar of UCR's core identity discussed by Provost Elizabeth Watkins - "A welcoming, inclusive, and collaborative community" and uphold it. We believe that the collective campus community needs to take specific actions to address this issue because the next hostile act may result in the physical assault of a staff or faculty member while on campus assuming that an assault of this nature hasn't happened already. We believe that an occurrence of this magnitude does not need to happen before UCR decides to act accordingly.

We request that the entire campus community, with special attention on senior leadership identified in this call to action, begin a series of conversations that will accomplish the following:

- 1. Evaluate and improve our current system of reporting that informs that entire campus community of all acts of violence, vandalism, and other hostile acts as it pertains to staff and faculty especially in instances not directly involving students.
- 2. Improve and implement campus wide safety measures, policies, and equipment designed to deter and prevent acts of destruction, violence, and hostility that create unsafe work, learning, and living environments.

BFASA is more than willing to help with the preliminary planning that will allow for the series of discussions that need to take place to begin as soon as possible. Feel free to forward this message to other UCR leaders not included in this message. Thanks for your time and consideration,
