

## 2021/2022 UC-HSI DDI President's Pre-Professoriate Fellows Application

Program Submission Deadline January 31, 2021

### ***Program overview***

The University of California (UC)–Hispanic-Serving Institutions (HSI) Doctoral Diversity Initiative (DDI) effort is designed to enhance faculty diversity and pathways to the professoriate for underrepresented students from California Hispanic Serving Institutions.

**The Pre-Professoriate Fellowship** will support a limited number of PhD students, who are California HSI alumni and have advanced to candidacy at UC, to foster their interest and preparation for the professoriate. Additional professional development support for underrepresented PhD students is also available to encourage and help equip them to consider careers in the professoriate.

Each UC Graduate Division will annually coordinate to identify and select two PhD student who have advanced to candidacy, by the time of selection, to be named *UC President's Pre-Professoriate Fellows*.

### ***Who is eligible to be named a fellow***

The programs' goal is to enhance faculty pathways for historically underrepresented groups, particularly Latinx, African Americans, American Indians/Native Americans, Filipinx, and Pacific Islanders in all disciplines; women in STEM; and Asian Americans in the humanities and social sciences. The intent of the program is to provide fellowships for domestic historically underrepresented minorities from California HSIs. For purposes of this fellowship, AB540 students are eligible. International students are not eligible for this fellowship.

This Fellowship program is only available to UC doctoral students who are matriculated in academic PhD programs and have advanced to candidacy. Professional students (e.g. M.D., J.D.) are not eligible.

### ***Program Expectations***

Recipients must be registered and enrolled in at least 12 units during the entire academic year. At the time of each payment's disbursement, recipients must have a cumulative GPA of at least 3.0 and maintain at least a cumulative 3.0 GPA during the entire term of the award.

Awardees may not work more than 25% time.

### ***General guidelines***

*Support for individual selected fellows*

UCR Graduate Division will name two (2) UC President's Pre-Professoriate Fellows each spring with the award applied the following academic year.

Fellows must have advanced to candidacy prior to being selected for the fellowship.

Fellows will receive a \$30,000 stipend for one academic year.

Graduate Divisions will also receive a \$10,000 grant to administer for each fellow for use during her/his PhD tenure for professional development opportunities that will expose, prepare and inspire them to pursue the professoriate.

### *Eligibility Criteria*

The program is open to UCR PhD students in all fields of study who:

1. Must be exceptional students (as demonstrated by their research achievements).
2. Must have received their undergraduate or master's degree from a California Hispanic Serving Institution (CA HSI)—public or private.
3. Must have advanced to candidacy prior to being selected for the fellowship.
4. Must have letters of support from Faculty Advisor(s) that address the student's performance and potential as an exceptional academic, and comment on the likelihood that the student will pursue a professoriate path after receiving their PhD.
5. Must have a demonstrated record of advancing issues of inclusion, equity, and diversity; actively supporting underrepresented communities; and shows commitment to pursuing these efforts throughout their career.

### *Application Procedure*

The applicant must follow the graduate program's instructions for deadlines to complete the application form, including the research statement. Two letters of recommendation from faculty are required for each nominated application; one letter must be from the dissertation adviser. Programs will submit final applications from nominees no later than January 31, 2021. Please Note: students SHOULD NOT submit their application directly to Graduate Division. All applications are to be submitted to the student's department/program.

**The diversity statement is required and evaluated as an important consideration for this award. Thus, applications lacking a completed diversity form will not be considered for funding.**
