Consent to Act as a Research Subject

The influence of the COVID-19 pandemic on college students of color and their experience with returning to campus.

You are being asked to participate in a research study. Before you give your consent to volunteer, it is important that you read the following information and ask as many questions as necessary to be sure that you understand what you will be asked to do.

Purpose of the Study:

This study will examine the impact of the COVID-19 pandemic on college students of color, evaluate the importance of health protocols, and assess the effect of the COVID-19 pandemic on everyday living, and mental well-being, and experiences of unfairness among college students from communities of color. This study will also examine the impact of returning to campus during the COVID-19 pandemic. Close to about 100 college students of color (18 years or older) currently attending a CSU university, a UC university, a private university, a trade/vocational school, or a community college will be interviewed through a survey.

Description of the Study:

You will be asked to complete an online survey about your experiences during the COVID-19 pandemic and your comfort in returning to campus. Questions are about your socio-demographic information, social relations, health, daily activities, feelings, moods, and comfortability with returning to campus. Your responses to the survey are completely voluntary, and you have the right to skip any questions you do not wish to answer. To be eligible for this, you need to be at least 18 years old, currently in college, and a student of color. If your responses indicate that you are not eligible, the information obtained during screening will be omitted from the study and removed to protect your privacy.

<u>Risks or Discomforts</u>: Because of the unique nature of the questions included in the survey, there could be occasions where you may recall unpleasant experiences or feelings. If you start to feel uncomfortable, you may discontinue your participation, either temporarily or permanently, and it will not impact your relationship with the researcher. Confidentiality:

We assure you that your information will only be used in academic research and kept confidential during this process.

Incentives to Participate: There is no incentive.
