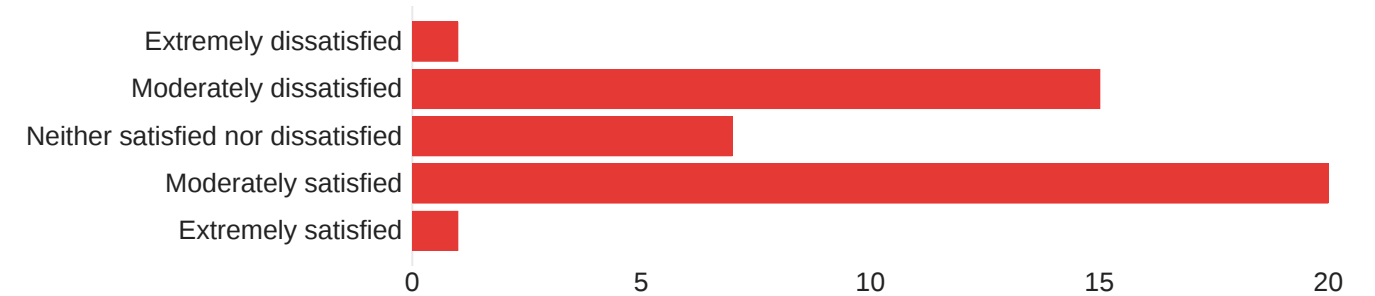


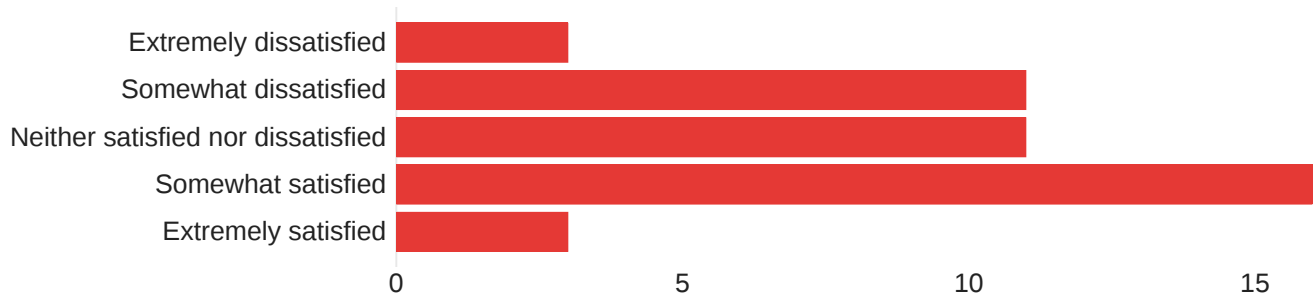
QID1 - Generally, how satisfied are you with the department?

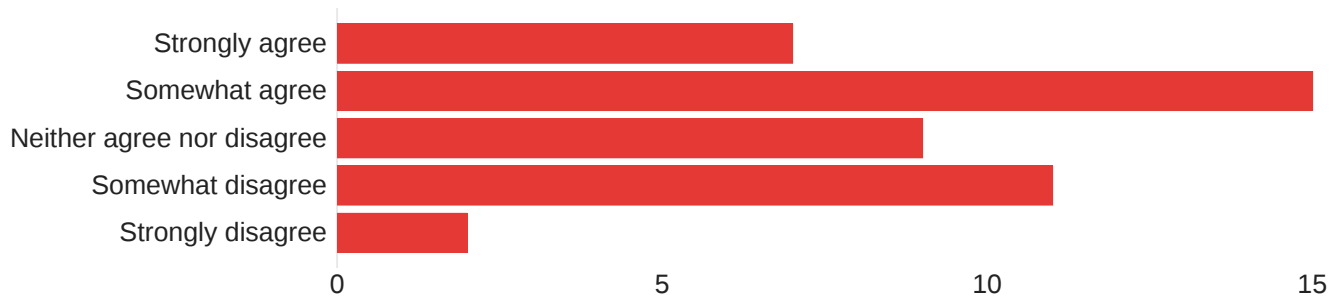
Q2 - Generally, how satisfied are you with the training offered by the department?

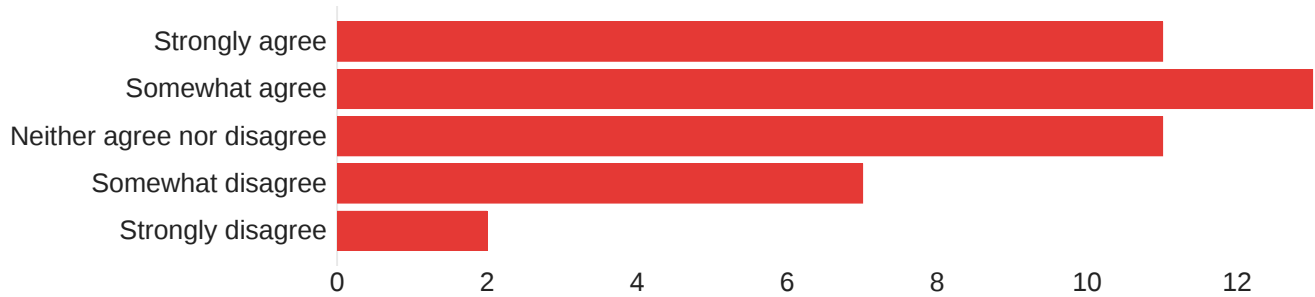

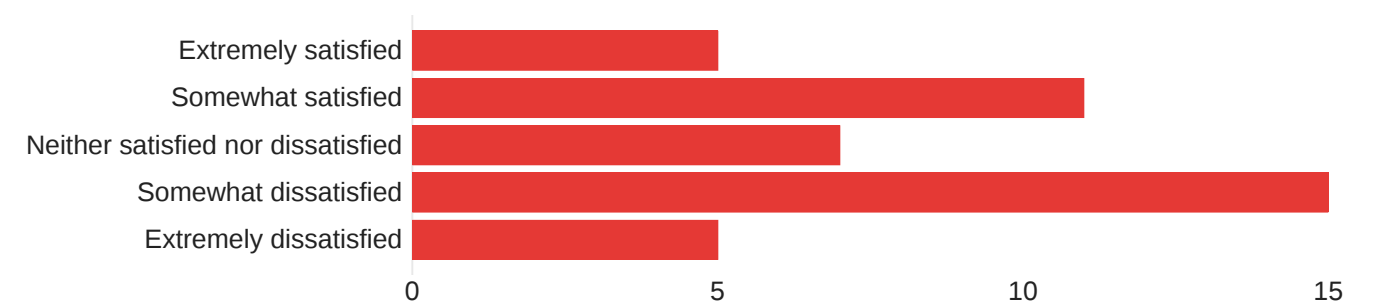

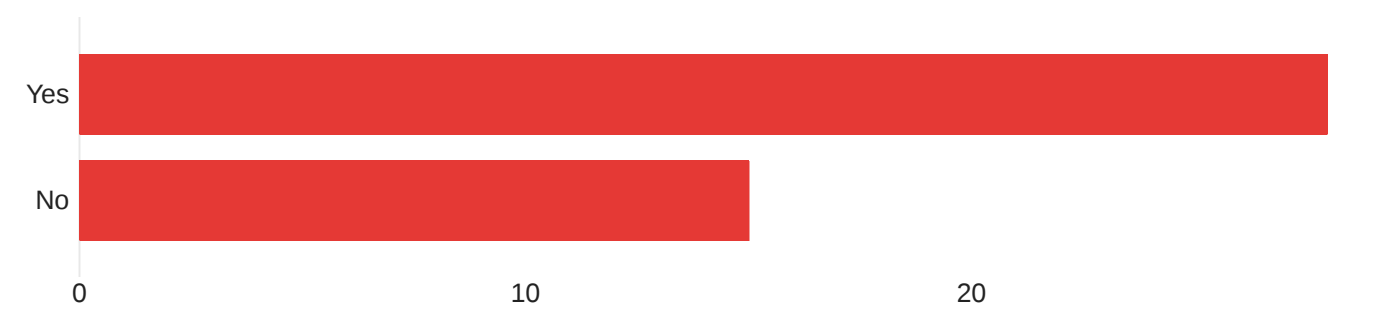
Q6 - Generally, are you satisfied with the courses available each quarter?

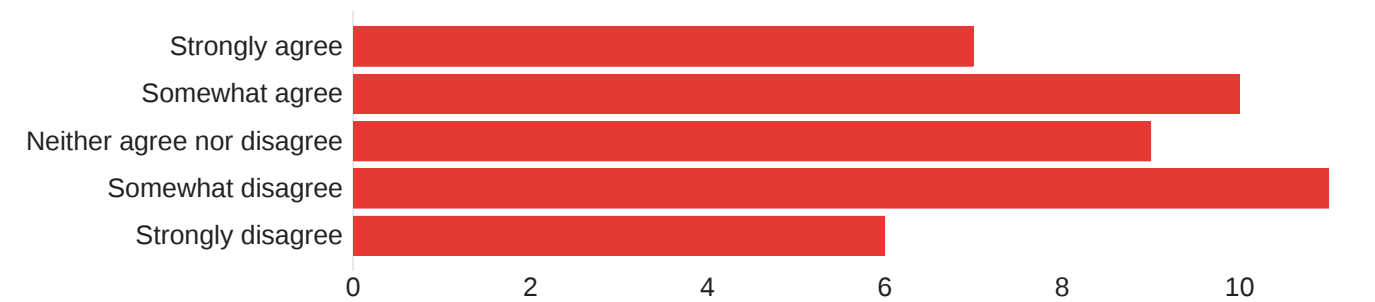

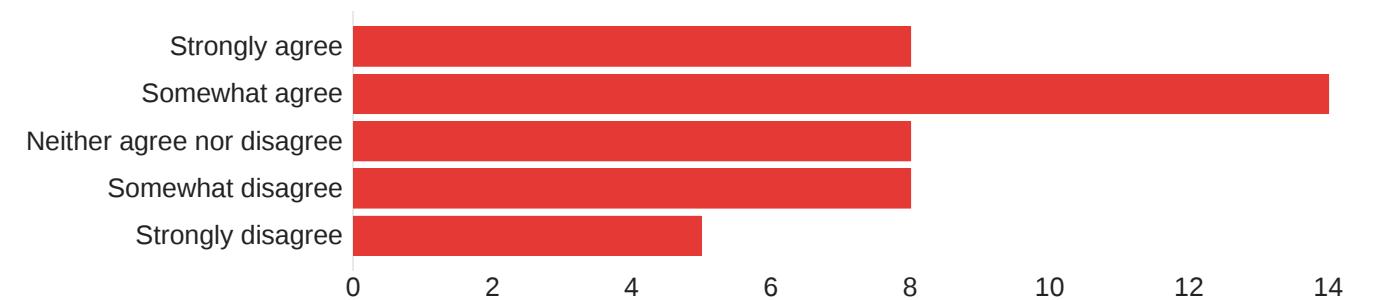

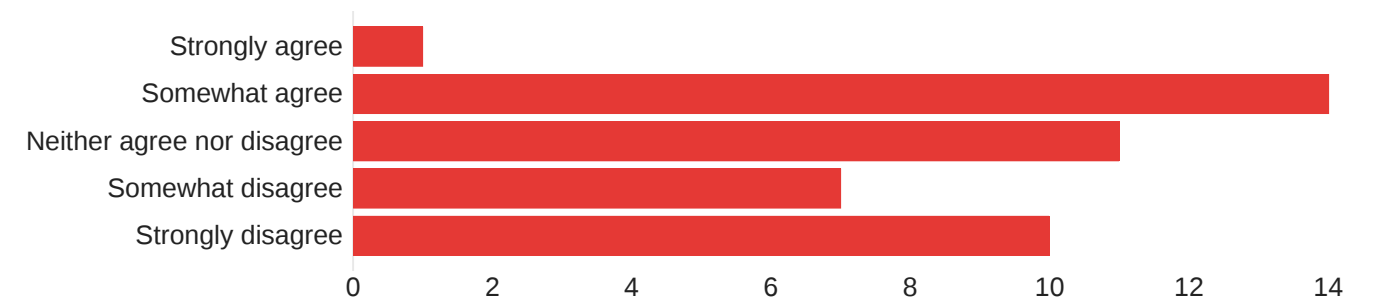
Q13 - Do you agree or disagree with the following statement: The department prepares students for the job market.

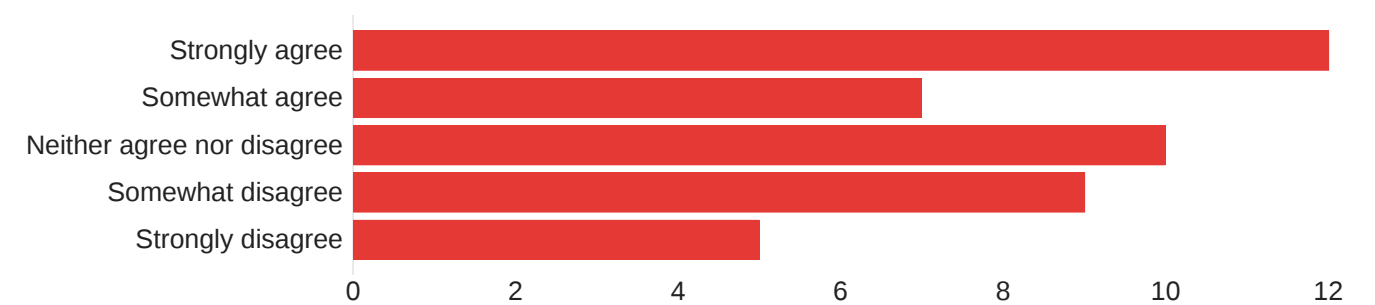

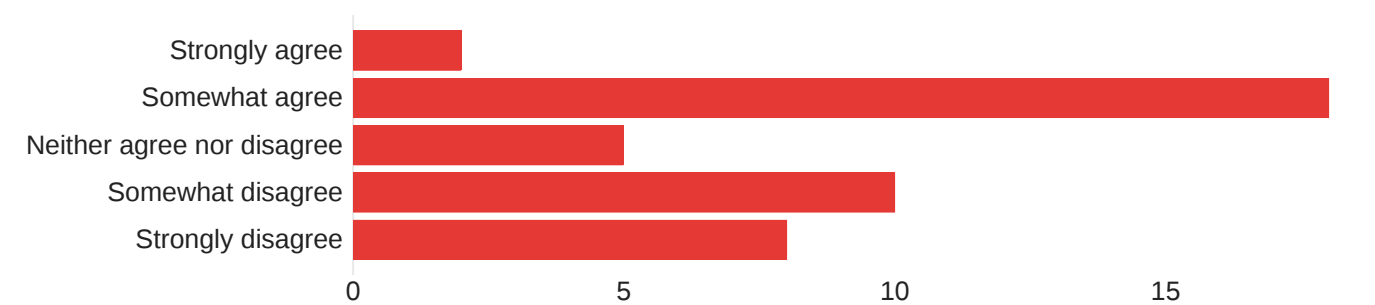
Q17 - Do you agree or disagree with the following statement: I feel comfortable talking about careers outside of academia with faculty.

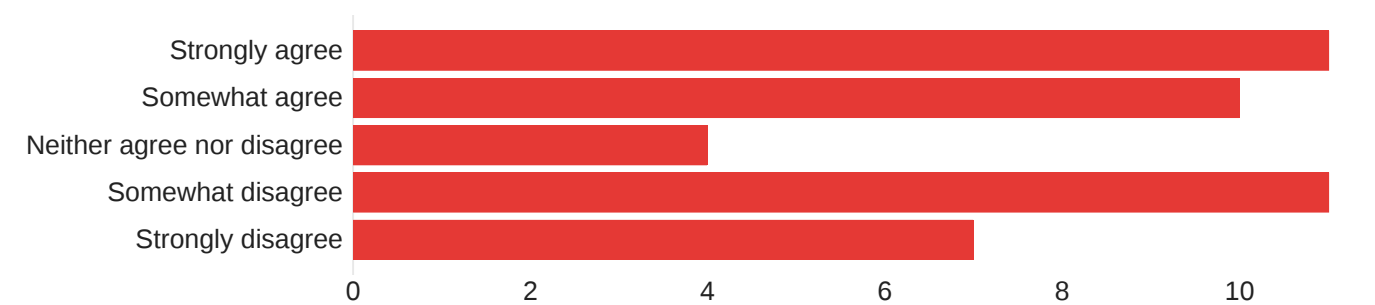
Q18 - Generally, do you feel a sense of community in the department?

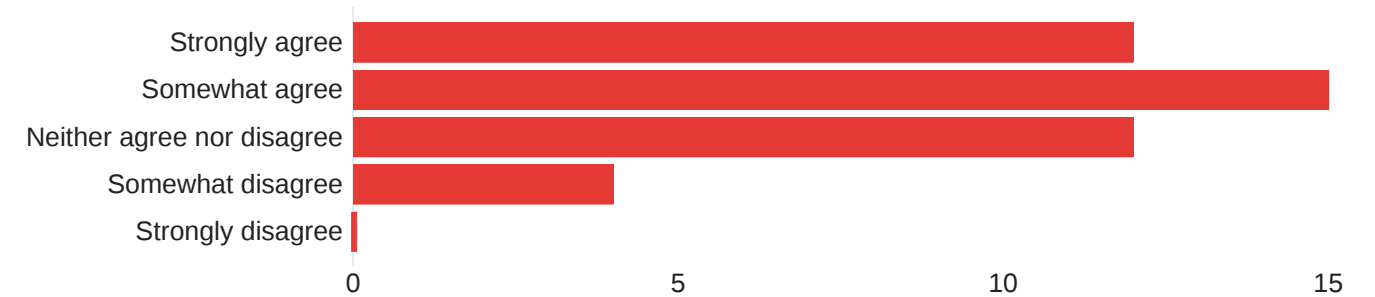
Q19 - Generally, do you feel a sense of community with your cohort?

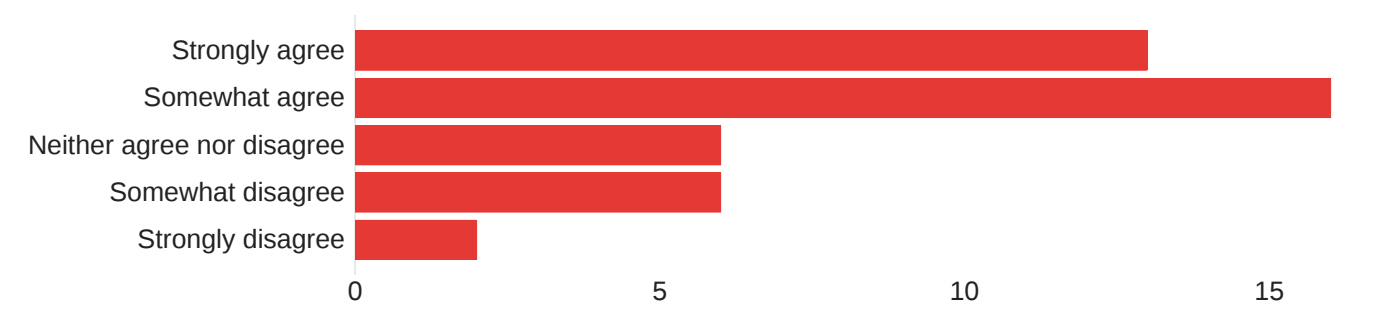

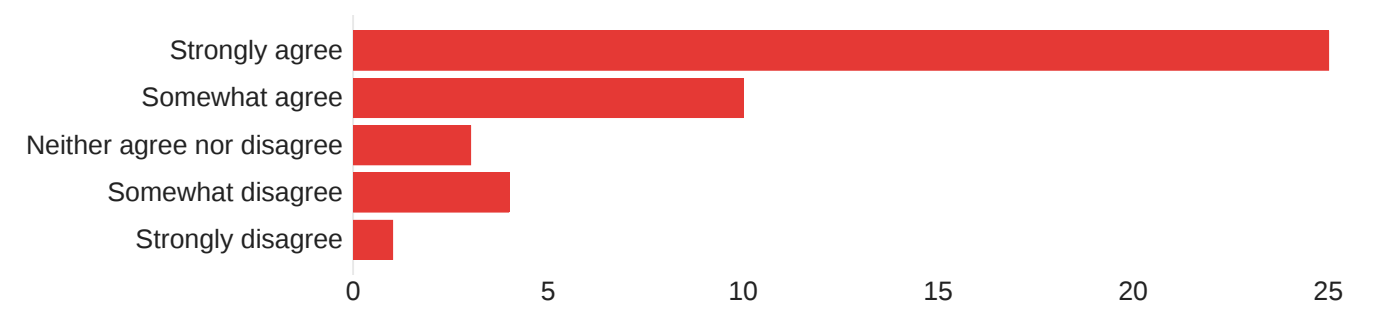

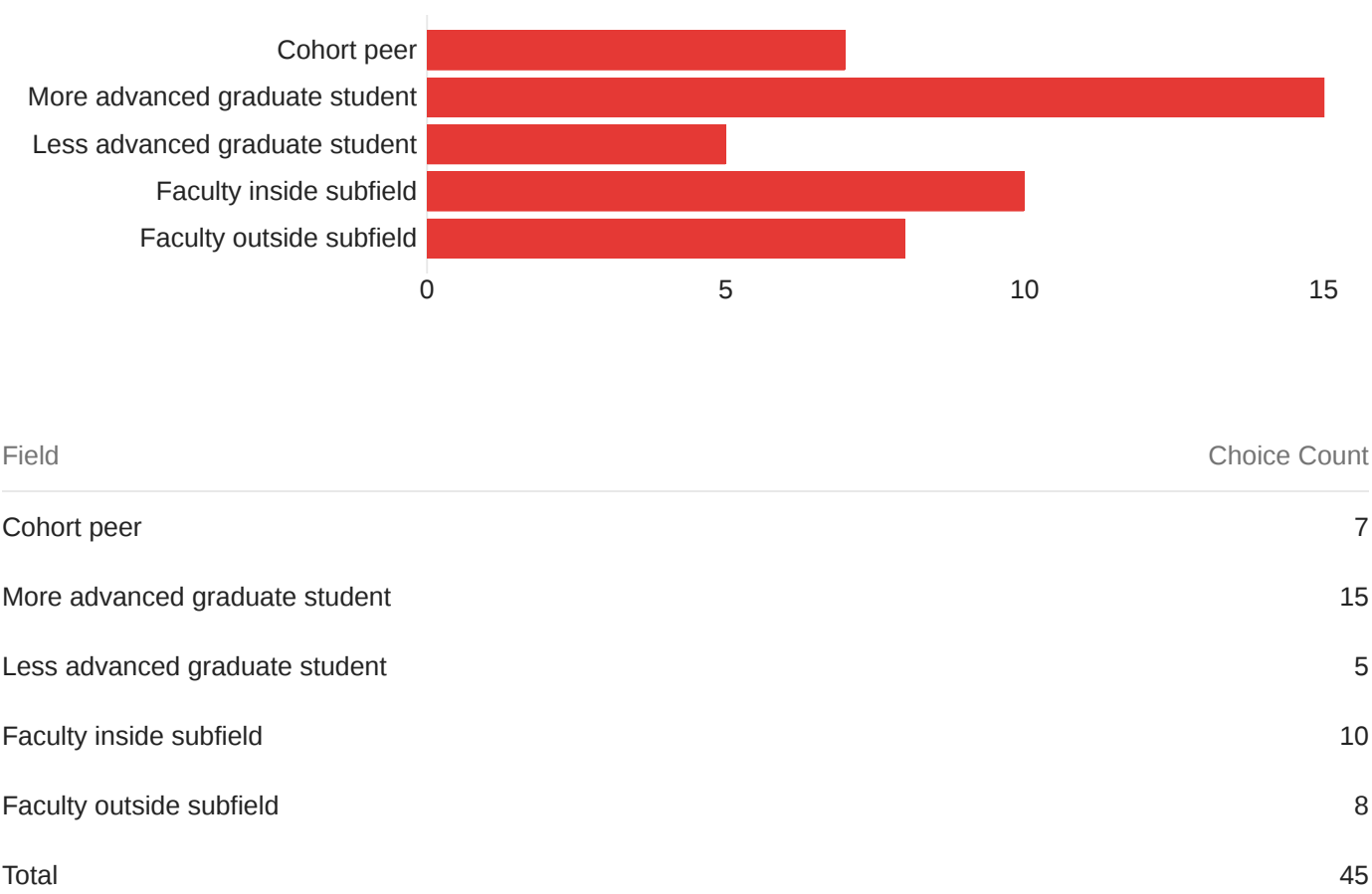
Q22 - Do you agree or disagree with the following statement: In the past six months, I worried about money.



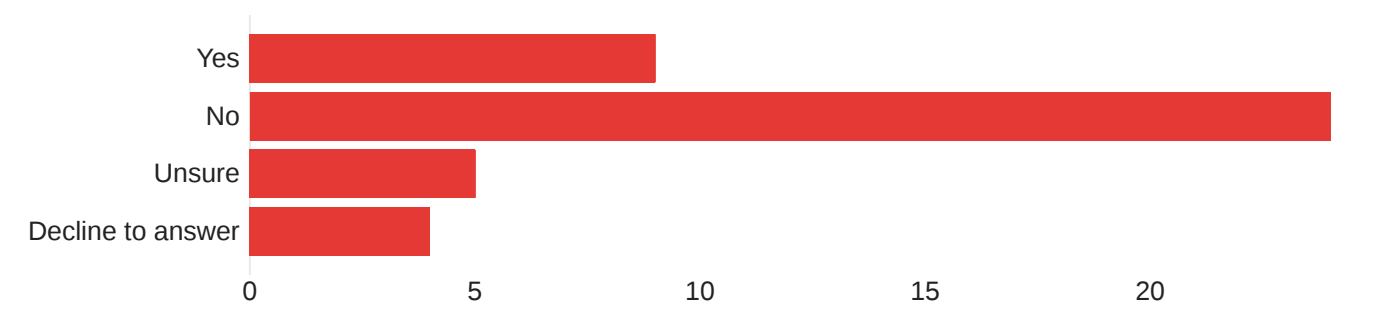

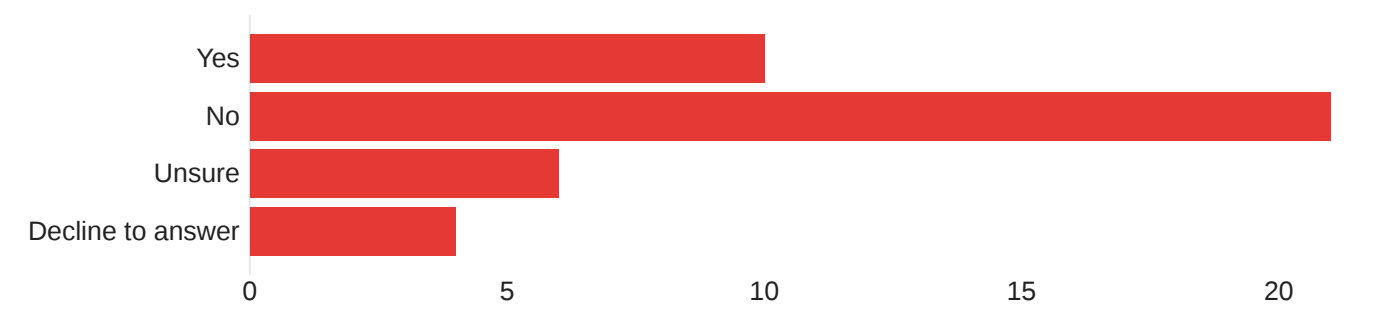

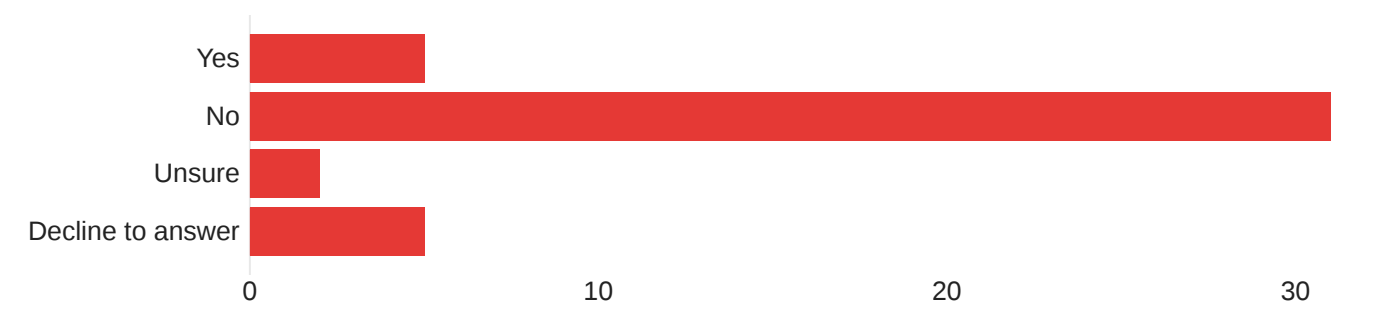
Q28 - Have you experienced discrimination or harassment because of your race, ethnicity, or national origin?

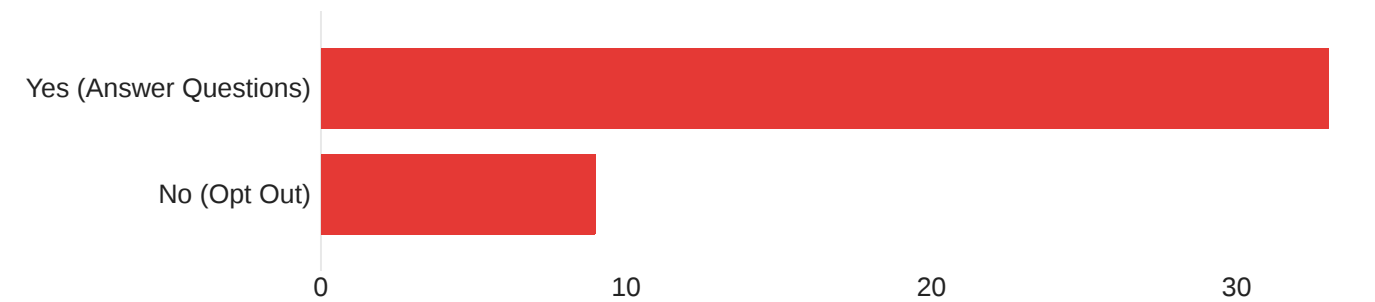
Q44 - Have you experienced discrimination or harassment because of your religion?

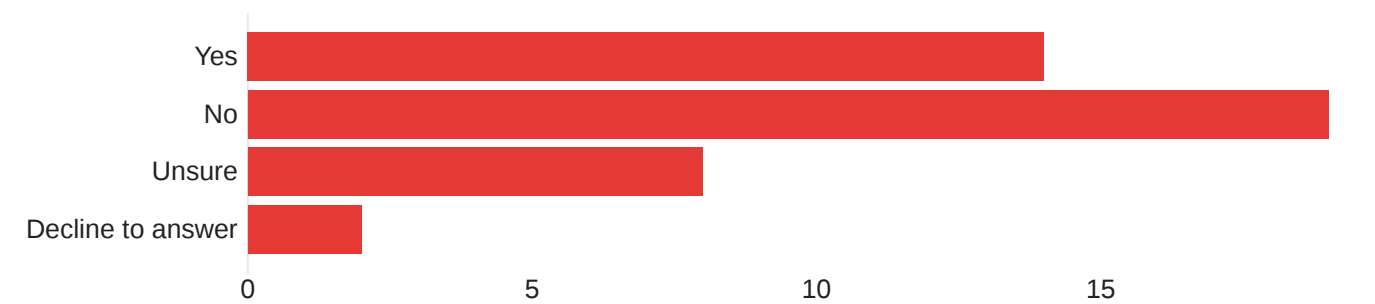

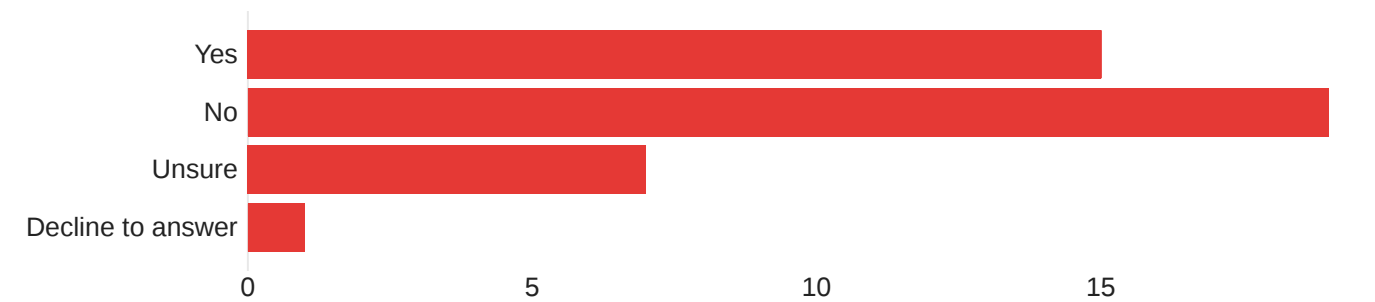

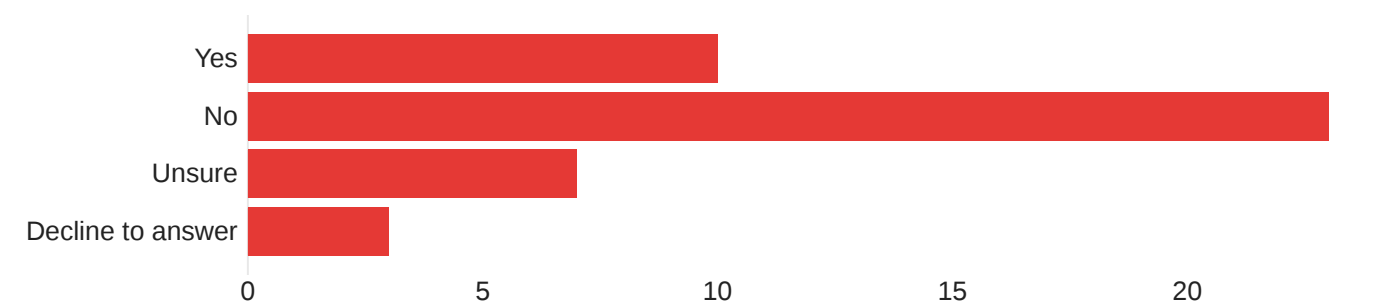

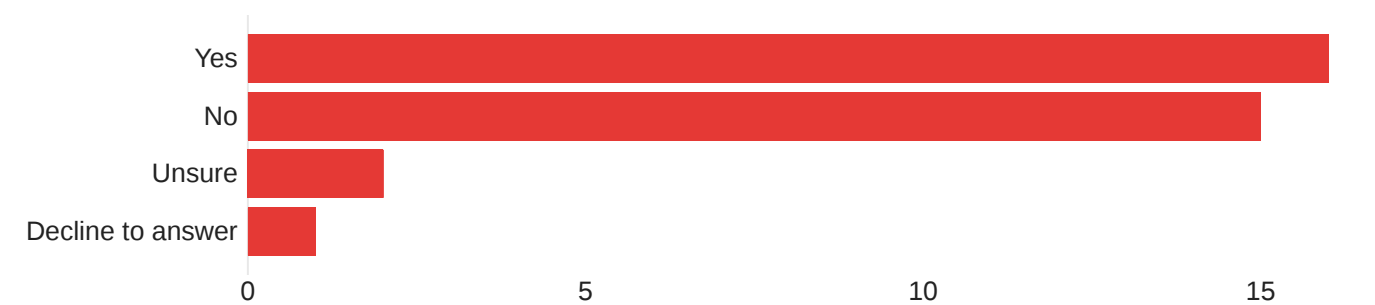
Q43 - Have you witnessed discrimination or harassment against a peer because of religion? Or has a peer confided such experiences to you?

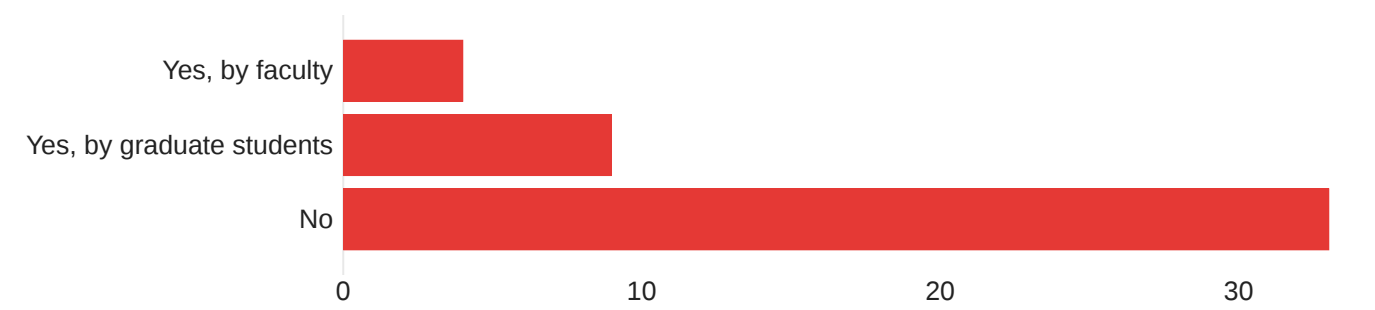
Q32 - Have you witnessed sexual harassment against a peer? Or has a peer confided such experiences to you?

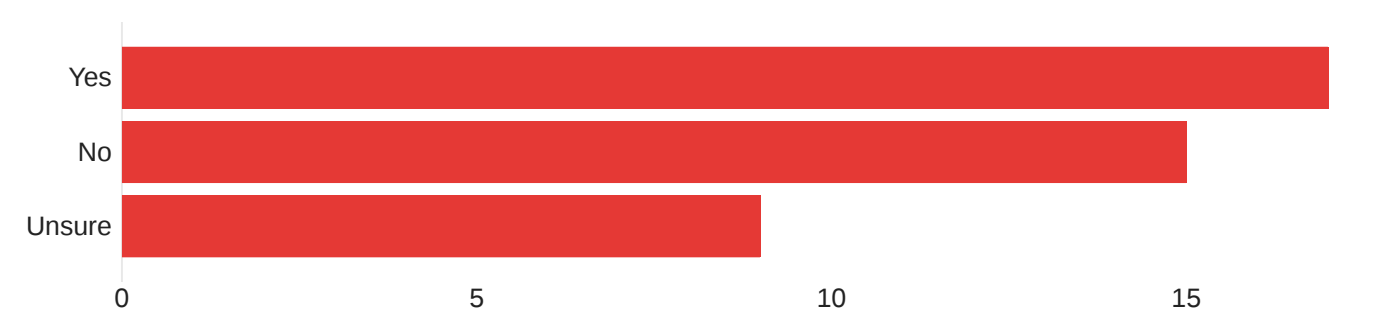

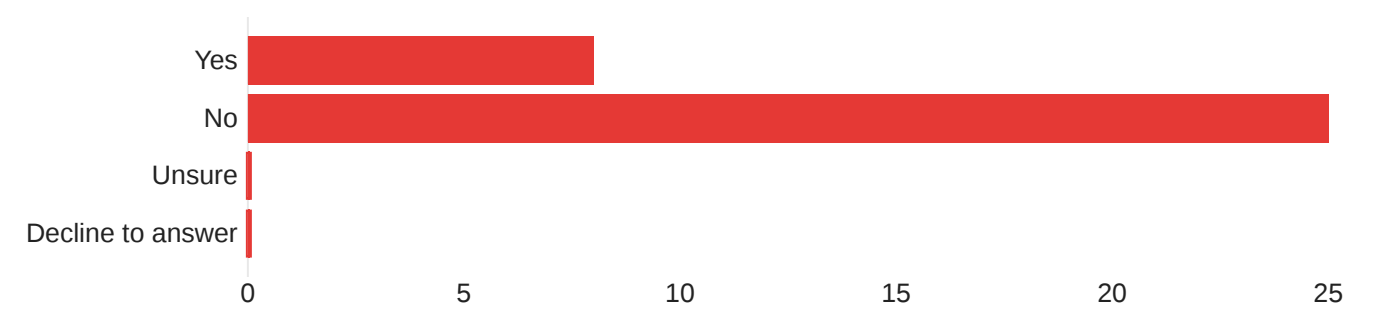
