



2023 Reception Honoring Retirees and Emeriti By Andy Plumley

On November 9, 2023, a reception was held to honor all our Retirees and Emeriti. Chancellor Kim Wilcox was there to thank retirees and emeriti for the role they played in UCR becoming a member of the Association of American Universities (AAU), an association of leading comprehensive research universities distinguished by the breadth and quality of their programs of (a) academic research and scholarship and (b) graduate education.

The Chancellor provided a presentation on UC Riverside's journey to becoming a member of the AAU.

- Enrollment, growing from 589 in 1954 to almost 27,000 today;
- Research expenditures and awards reaching almost \$200M;
- Achieving rankings which includes being ranked in the top 1.3% of Universities Worldwide, #1 in Pell Grant Retention (Chronicle of Higher Education) and #2 in Social Mobility (US News);



Chancellor Wilcox ended his presentation on how UCR leads with a unique profile that provides opportunities for the future. The UCR Retirees' and Emeriti Associations were privileged to host this recognition event and provide continuing support to our retirees and emeriti.







Walks, Talks & Tours

Center for Environmental Research and Technology (CE-CERT) Tour



UCR Retirees and Emeriti took a tour of the Bourns College of Engineering-Center for Environmental Research and Technology (CE-CERT) in October to learn about a wide array of research into air quality and energy.

CE-CERT is a UCR laboratory occupying three buildings a few miles north of campus, next door to Bourns Inc. Associate Director Arun S.K. Raju guided visitors through indoor and outdoor facilities where UCR faculty, students, and research staff investigate technologies to improve air quality, energy efficiency, and sustainability.

CE-CERT originally concentrated on controlling emissions from cars and trucks through fuel chemistry, combustion management, alternative powertrains, and smart traffic systems. Its portfolio has expanded to include research on emissions from aircraft, ships, restaurants, and consumer and industrial products and processes. CE-CERT has worked to establish itself as an "honest broker" trusted by regulators, industry, and the public to study environmental issues and point the way toward consensus on solutions.



In addition to producing important basic and applied research results, that role also contributed to the California Air Resources Board's decision to move its research laboratory to Riverside two years ago. CE-CERT and BCOE are cultivating adjunct appointments and joint projects with CARB staff to create new opportunities for research that benefits the public and unique educational opportunities for students.

Report on the October 17, 2023 Dickson Lecture By John Briggs "Thinking Like an Actor" by Eric Barr



Aging, illness, and retirement can and do pose many challenges to retired faculty and staff. Add a series of strokes, paralysis, and a dose of confusion to the mix and you have grounds for appeal. Professor Emeritus Eric Barr, who underwent a series of strokes in 2013 that led to those devastating events, found a way to engage his condition by using strategies he had developed as an actor and professor of theater. Thirteen years later, he travels widely to tell his audiences what he did, what he continues to do, and what he has learned from his experience.

The lecture Eric presented on October 17 was about something bigger than theater and acting, as we typically think of them. It was about "acting and being": the rediscovery of "the character called you" that must be developed by means of "choices" and "commitment" to those choices. In his paralysis, he imagined himself becoming more fully human as "the new character called you." With patience and the help of others, he slowly began to reclaim "a sense of self," learning how to do the most basic things: sitting up, concentrating, observing, smiling, and speaking – by means of grounded imaginative projection and persistent practice. He began to play the story of his life, discover the wonders of ordinary existence, and recover a sense of self and a lost ordinary world.

A key to this gradual transformation was recovering what was present: being awake to one's surroundings and the powers of mind and emotion to apprehend the world feelingly, undistracted by errant thoughts or, when it comes, seemingly relentless pain. There was no easy progress or success according to plan. There had to be patience and a certain kind of humility in the actor's needing to create "the illusion of the first time" – to be "alive and living in the moment," a beginner again.

The power of imagination is not always good. It can be a "poison" if there is no acceptance of what comes to us and our dependence upon others in the imperfect work of recovery. Say "yes, and" Eric said, not "yes, but." It is important to play the part given to us in our "improvisational moment," not according to a wishful imagination of the "end of the story." That is why playfulness is so important. "Candy is a great lubricant." One source of inspiration was Norman Cousins' playful, industrious and ingenious overcoming of a seemingly hopeless prognosis, thanks in part to a generous helping of Marx Brothers movies and an openness to joy, laughter, and happiness (Anatomy of an Illness).

Eric concluded with a reminder that for most of us, our lives will be changed by events that we do not control. What then? "I found, "he concluded, "that the key to restoring my life was discovering what is important to me."

2023-2024 Distinguished Emeriti Award Recipients: Ernest Ma and Prasanta K. Pattanaik By Dallas Rabenstein

Emeritus Professor of Physics Ernest Ma joined the faculty of the Department of Physics in 1987. Following his retirement in July 2014, he has maintained an outstanding record of accomplishment in his field of theoretical physics, with an emphasis on theoretical neutrino physics.

In his research since retirement, Professor Emeritus Ma has continued his scholarly activities with a high rate of productivity. To quote a colleague: "Since his retirement in 2014, Ernest wrote a superhuman 84 published papers", which is more than 8 papers per year. Seventeen were published with UCR graduate students. These papers have accumulated more than 1400 citations, not including self-citations. One paper has been cited more than 100 times, another has been cited more than 140 times and ten others each have more than 50 citations, an indication of the continuing high impact of his research since retirement.



Professor Ma has given more than 45 invited conference, workshop, and seminar talks, all but one of which were at international venues. He also has served on the scientific advisory board of two international conferences. Although he became an emeritus professor in 2014, he continued to receive grant support for his research in neutrino physics from the science office of the Department of Energy until 2018.


Since his retirement, Professor Ma has continued to be a member of the particle physics group at UCR, and he has been active as a mentor of junior theoretical particle physics faculty. He also has graduated six Ph.D. students since retirement.

With his outstanding record of accomplishment since retirement, Professor Ma is a most deserving recipient of the Distinguished Emerita/Emeritus Award.

Emeritus Professor of Economics Prasanta K. Pattanaik joined the faculty of the Department of Economics in July 1991. Since retirement in June 2007, he has continued to distinguish himself through his scholarly activity. He has worked mainly in the areas of welfare economics, the measurement of deprivation and living standards, and development economics.

Since retiring, Professor Pattanaik has published one book and edited four others. Three of these were published by Oxford University Press. He has published 31 articles and book chapters, which is about one book every 4 years and 2 articles/chapters per year.

Distinguished Emeriti Award Recipients continued



He has presented 9 lectures at various international venues. To quote one of his colleagues: "Professor Pattanaik was a prolific and influential scholar prior to retirement, and it is no surprise that he has continued on this path since retirement".

The continued impact and influence of Professor Pattaniak's research is reflected in the many awards he has received since retiring. Since 2001, he has been a non-resident Honorary Distinguished Fellow of the Indira Gandhi Institute of Development Research, India. In 2020, he was honored with the Padma Shri award, one of India's highest civilian awards, awarded by the President of India. From 2014-2015, he was president of the Indian Econometric Society. He also has been a visiting scholar/professor at the University of Massachusetts, Amherst; the University of Bath, UK; and Oxford University, UK.

In addition to his continued research activity, Professor Pattaniak has continued to teach in the Department of Economics, teaching two graduate courses and seven undergraduate courses since he

retired.



Report from UCREA's Spring 2023 Graduate Student Awardee

I would like to extend my warmest gratitude to the donors who support the UCREA Graduate Student Travel Award, which enabled me to travel to the International Meeting of Organic Geochemistry (IMOG) in Montpellier, France.

I am a 5th year PhD candidate in the UCR Department of Earth and Planetary Science, and a geobiologist who tracks the coevolution of life and the environment on very ancient Earth in my research. The tool I use is lipid biomarkers or molecular fossils, organic compounds produced by



living organisms that survive in rocks for hundreds of millions of years after the organisms that die. Specifically, I study the fossil record of steroids, a class of compounds produced by most eukaryotes, from humans to algae, plants, and single-celled protozoans, to track the rise of eukaryotes – that's all life with a nucleus, or all complex life on Earth. Based on my research, we have determined that eukaryotic algae (the basis for the Earth's most productive marine ecosystems today) became abundant in the oceans around 800 million years ago, enabled by an increase in nutrients to the oceans that may have been triggered by the breakup of the supercontinent Rodinia, but that different environments had a biological heterogeneity similar to what's seen in the oceans today. My research has also shown that the global Snowball Earth glaciations around 700 million years ago fundamentally changed the composition of the biosphere by giving rise to green algae, which later algae gave rise to plants. Thanks to the UCREA travel award, I was able to present these results at the main conference in my field.

At this year's IMOG, I gave a plenary talk, "The Rise of Eukaryotes Recorded by Tonian Lipid Biomarker Patterns and Biomarker Stratigraphy", attended by most of the conference's several hundred attendees, after which I received a number of detailed technical questions and considerable praise. I was able to make connections with an Omani researcher who I have been trying to get access to samples from for months, and had dinner with two of the biggest critics of my advisor's work, both of whom live in Europe and I would otherwise not be able to interact with. I had several senior faculty members offer to collaborate with me after my talk. Most meaningfully for me, I was able to build connections with one of the pioneers of ancient biomarker study, who retired this year and was delighted by my talk. Attending this conference gave me a sense of belonging in the organic geochemistry community that I had not previously felt, due to the isolation of the pandemic.

This conference was also my first time traveling to Europe or outside of North America. The UCREA travel award paid for my plane tickets as well as my shared lodging. Thanks to the flexibility of the award, I was able to stay in an AirBnb in a historic building in Montpellier, which added considerably to the cultural experience, and I was also able to travel on personal funds to Paris, where I visited cultural sites such as the Louvre and the Parthenon as well as the Marie Curie Museum at Sorbonne University, a site of great importance to me as a chemist. Attending the 2023 IMOG was a transformative experience for me, helping me build connections, share my science, and get my career on track, and I have returned more confident and focused and eager to publish my data.
